 - (a) The Facts. Details needed: Helen Garfield from New York looking for twin sister, Elaine/hasn't told police/disappeared a week before Helen came to see me/wouldn't tell me her address/ EG's address: Apt 716, Manson Building, Sunset Place/work address: Myer and Myer (Attorneys), Title-Insurance Building/EG at work on Monday, left suddenly in afternoon no one knew why/EG's apartment very tidy, wardrobe almost empty/hit on head.

What To Do Next: Possible answer: Recover from being hit/find out who hit me (2 men: One - Jo -short/redhair, one - tall, hat pulled down)/carry my gun in future/talk to HG again/talk to Myer and Myer. (b) The Facts. Details needed: A threatening phone call telling me to forget EG/Myer and Myer – Mr Myer knew nothing, Suzy Graham worked with EG/Suzy's information: didn't know EG had a sister/EG left work saying she didn't feel well/phone call just before she left/EG friendly with everyone/argument with SG at Las Cabanas Club (address: 232 Golden Drive. Tel. 323.0313) a month ago/EG had met 'wonderful man' -Benny Greep/SG said BG was 'no good'/Cleaner at Club: BG plays drums in a band (address: 5314 Arvieda St., W. Los Angeles)/BG's apt: untidy/BG dead in bath shot in chest/driving licence photo proved it was BG/phoned police/police arrested me.

What To Do Next. Possible answer: Get away from police station/talk to HG again/go back to Las Cabanas Club and find out about BG/talk to the porter at EG's apartment building.

(c) The Facts. Details needed: Questioned at police station by Sgt Murphy about murder/set free but followed by yellow car/letter from HG at office/met her at 11.30 pm at Las Cabanas: (How does she know about Las Cabanas?)/porter at Manson Building had phone number of Las Cabanas/at club - talked to HG - said she didn't know much about EG's life in LA/said she spoke to Mr Myer on Tuesday about EG/wouldn't tell me why she wanted to meet at the Club/she left me about midnight/attacked by Jo and tall man/hit again on the head. What To Do Next. Possible answer: Find out who hit me and why/find HG and ask her why she left me/ask her why she knew about Las Cabanas again/ask her about Benny Greep/find out why Las Cabanas is so important. (d) The Facts. Details needed: Learnt from Sgt Murphy that criminals own Las Cabanas/told him about HG but not EG/said he was going to find out about HG from NY police/agreed to tell him about BG and Las Cabanas when I found out anything/Myer never spoke to HG/didn't know EG had a sister till I told him/said Helen and Elaine sounded similar/realized I was only person to meet HG/Sgt Murphy found that HG didn't

exist/met HG at cafe/accused her of being EG/she is. What To Do Next. Possible answer: No money from this job – get another one/don't accept jobs from beautiful blonde girls/phone Suzy Graham and ask if weight-lifter is still her boyfriend.

 - (a) Sgt Murphy: meets Lenny when Lenny is arrested for BG's murder/tells two policemen (in the yellow car) to follow Lenny but loses track of Lenny when it crashes into the back of Lenny's car/meets him again when Lenny is picked up in the middle of Golden Drive and taken to police station/hears from Lenny about Las Cabanas and the fight and about working for HG/goes to arrest Lenny when he finds out HG doesn't exist/then is told the whole story by Lenny and EG. (b) Suzy: worked at Myer and Myer with EG/gave Lenny information at a cafe near the building where she worked - used to be friendly with EG/had an argument over BG at Las Cabanas a month before EG disappeared/thought BG was 'no good'/knew EG was seeing him/didn't go out with EG again/knew EG disappeared from work on a Monday afternoon - feeling unwell/didn't know she had a sister/spoke to Lenny on phone briefly - put Lenny through to talk to Mr Myer. (c) Jo: used to sell stolen jewellery at the Las Cabanas Club/found out that BG - the drummer with the band - and his girlfriend, EG, had stolen a bag of jewellery which he'd hidden in the club/EG disappeared from the club and her apartment/went with tall man to Manson Buildings after porter told him Lenny was investigating EG's apartment/didn't know why he was there/attacked him/went to BG's apartment/arranged with BG that EG would bring jewels back to club/killed BG/next night in Las Cabanas - EG ran away without leaving jewels, a fight with Samuel who escaped/phone call to Samuel that they would meet him at his office because he could lead them to EG/Samuel not there/car outside cafe/Samuel with EG and jewels but police there too.
